Simon and Psycho Bunny Sweepstakes Official Rules

You will automatically receive one (1) Sweepstakes entry. By completing the registration form, you are also agreeing to receive email marketing messaging from Simon Property Group and Psycho Bunny Inc. You may withdraw your consent to receive email marketing messaging at any time without affecting your Sweepstakes entry.

<u>Limit</u>: Each entrant may receive one (1) Sweepstakes entry by registering at the website listed during the entire Promotion Period. Multiple entrants are not permitted to share the same email address. Any attempt by any entrant to obtain more than the stated number of entries by using multiple/different email addresses, identities, registrations and logins, or any other methods will void that entrant's entry and that entrant maybe disqualified.
