<u>Mall Insider</u>: Visit https://www.simon.com/mall-insider and follow the links and instructions to create or log into your Mall Insider account (also an "Account") and confirm entry into the Sweepstakes. Accounts are free, but subject to the terms of use as outlined here: https://www.simon.com/legal. You will automatically receive one (1) Sweepstakes entry.

<u>Limit</u>: You may enter one (1) time per method during the Promotion Period. Multiple entrants are not permitted to share the same email address or Account.
