Official Rules and regulations

1. **PROMOTION:** This Promotion begins on Thursday, March 20, 2025, at 10:00 a.m. EDT and ends on Sunday, April 13, 2025, at 6:00 p.m. EDT (the “Promotion Period”). Participation in this Promotion constitutes your full and unconditional agreement to and acceptance of these Official Rules and Regulations and decisions of Mall at Potomac Mills, LLC (the “Sponsor”) which are final and binding in all respects. Official time is based on Sponsor’s computer.
