Official Rules and Regulations

1. **ENTRY:** This promotion (the “Promotion”) takes place from Saturday, November 1, 2025 at 10:00 a.m. EDT through and including Saturday, December 20, 2025 at 10:00 a.m. EDT (the “Promotion Period”).
