

Spring Receipts to Rewards (the “Promotion”)
Waikele Premium Outlets (“Participating Center”)
Official Rules and Regulations (“Official Rules”)

IMPORTANT: THESE OFFICIAL RULES ARE MADE SUBJECT TO THE [SIMON TERMS OF USE](#), WHICH REQUIRE RESOLUTION OF CERTAIN DISPUTES BY INDIVIDUAL ARBITRATION AND INCLUDES A WAIVER OF YOUR AND SIMON’S RIGHTS TO HAVE ANY SUCH DISPUTES DETERMINED BY A COURT OR BY A JURY OR BY CLASS ACTION, AS DESCRIBED IN SECTION 9 BELOW. FURTHERMORE, SECTIONS 5, 7(d), AND 9 BELOW CONTAIN WARRANTY DISCLAIMERS, RELEASES, AND LIMITATIONS ON LIABILITY THAT YOU SHOULD REVIEW.

1. **PROMOTION:** The Promotion will begin on Wednesday, April 29, 2026 at 10:00 a.m. HDT, and end on the earlier of Tuesday, June 30, 2026 at 7:00 p.m. HDT **or the time that all Promotional Items (as defined in Section 4 below) are claimed by the first 1.200 eligible Participants to appear at the Registration Site(s) while supplies of Promotional Items last** (the “**Promotion Period**”). Participation in this Promotion constitutes your full and unconditional agreement to and acceptance of these Official Rules and decisions of Premium Outlet Partners, L.P. (“**Sponsor**”) and it’s Third-Party Administrator, defined below in Section 3(b), which are final in all respects.
2. **ELIGIBILITY:** Not open to residents of Rhode Island. Open to legal residents of the remaining 49 United States, Washington, D.C., and Puerto Rico, not including any commercial entity. You must be 18 years of age or older at time of submitting your Entry. Void where prohibited by law. Employees, directors, officers, agents, and representatives (each a “**Representative**”) of Sponsor, Simon (as defined in Section 7(b) below), all Providers (as defined in Section 5 below), all Retailers (as defined in Section 7(b) below) and their affiliates, suppliers, advertising, promotional, or judging agencies providing or participating in any portion of the Promotion (each a “**Promotion Party**” and collectively the “**Promotion Parties**”); and the immediate family members of Representatives of the Promotion Parties are not eligible to participate. Receipts must be validated and redeemed at one of the Registration Sites (defined below in section 3(b)) on the same day of the qualifying purchase during the Promotion Period. Qualifying receipts will be stamped for acknowledgement by Sponsor. Receipts without a date will not be honored. No photocopied, mechanically reproduced, or electronic receipts will be accepted. Offer not valid towards purchases made prior to the Promotion Period.

- b. The redemption period for this promotion occurs on Wednesday, April 29, 2026 from 10:00 a.m. HDT and ends on Tuesday, June 30, 2026 at 7:00 p.m. HDT (the “**Redemption Period**”). Receipts may be presented at the Mall Management Office at the Waikele Premium Outlets, 97-790 Lumiaina Drive, Waipahu, HI 96797, Monday through Friday only from 9:00 a.m. to 5:00 p.m. HDT or at Sponsor’s Third-Party Administrator, Diamond Head Chocolate, located in Unit ID 416 at Waikele Premium Outlets (**each a “Registration Site” and collectively, the “Registration Sites”**) during the Promotion Period.
 - c. For completing an Entry, Participant will receive one (1) Promotional Item, as defined below. **THIS PROMOTION IS LIMITED TO ONE (1) PROMOTIONAL ITEM PER PERSON AND WILL ONLY BE REDEEMABLE BY THE FIRST 1,200 ELIGIBLE PARTICIPANTS TO APPEAR AT THE REGISTRATIONS SITE(S) WHILE SUPPLIES OF PROMOTIONAL ITEMS LAST.** Chances of winning depend on the number of Participants who present \$350.00 or more in same day receipts for purchases made during the Promotion Period at Waikele Premium Outlets. also be available at the Registration Sites. All monetary amounts stated in these Official Rules are in United States Dollars.

NEITHER SPONSOR NOR ANY OF THE PROMOTION PARTIES HAVE MADE OR MAKE OR ARE RESPONSIBLE OR LIABLE FOR ANY WARRANTY, REPRESENTATION, OR GUARANTEE, EXPRESS OR IMPLIED, RELATIVE TO THIS PROMOTION OR ANY PROMOTIONAL ITEM, INCLUDING BUT NOT LIMITED TO, THE QUALITY OR FITNESS FOR ANY PARTICULAR PURPOSE OR MERCHANTABILITY OF ANY PROMOTIONAL ITEM.** Promotional Items are provided for individual, personal use and may not be resold or used (and Sponsor hereby disclaims any appropriateness of any Promotional Item) for any commercial purpose. Any Promotional Item (including, without limitation, any gift card, or certificate, voucher, discount, or coupon awarded as a Promotional Item) may be subject to additional terms and conditions applicable to such Promotional Item (including, without limitation, applicable expiration period, minimum purchase requirements, etc.) as determined by the issuer, manufacturer, or provider ("**Provider**") of such Promotional Item to Sponsor (see the Promotional Item or Provider (or both) for details) and no other Promotion Party (besides the relevant Provider) has any responsibility and provides no warranty or representation regarding any such additional terms or conditions of any Promotional Item to any Participant. 7. **ADDITIONAL CONDITIONS OF PARTICIPATION:** By submitting an Entry or otherwise participating in this Promotion, Participant acknowledges and agrees that Participant's participation in this Promotion is expressly subject to the following additional terms and conditions:
 - a) Participant shall have no right of approval of any use by the Promotion Parties of any data or materials (including, without limitation, any photograph, video, or audio capture including Participant's likeness or voice) submitted in any Entry or otherwise provided to or captured by the Sponsor related to this Promotion ("**Participant Materials**") subject to applicable law. Thus, Participant has no right to any payment, royalty, or other monetary compensation for the Promotion Parties' use of the Participant Materials and, without limiting anything else in these Official Rules, Participant has no (and hereby waives any) Claims (as defined in Section 7(d) below); including, without limitation, Claims

based upon copyright infringement, invasion of privacy, defamation, false association, infringement of moral rights, or infringement of any right of publicity) arising out of any use, copying, distribution, blurring, alteration, distortion, illusionary effect, faulty reproduction, fictionalization, or combination with any other materials of the Participant Materials. You further waive and release any and all “moral rights” you may have in your Participant Materials.

- b) Participant grants Sponsor the right to contact you by any contact method contained in your Entry including, without limitation, via telephone or electronically, to communicate with you regarding your Entry in this Promotion. If you provide your email address or mobile number (or both) as part of your Entry and consent to receiving promotional messages from Sponsor, Participant agrees to receive ongoing email or text (SMS or MMS) (or both) promotional messages including, without limitation, special offers, notice of sales, new store openings and features, contests, and other promotional announcements and offers from Sponsor and entities affiliated with Sponsor including, without limitation, Simon Media Properties, LLC, Simon Property Group, L.P., and Simon Property Group, Inc. Any Participant

determined by Sponsor, at its sole discretion, to have been engaged in or attempted Cheating will be immediately disqualified and will forfeit any right to a Promotional Item or be obligated to refund the Promotional Item to Sponsor if already awarded.

- f) Sponsor reserves the right, in Sponsor's sole discretion, to disqualify any Participant who Sponsor determines is inconsistent with the values of the Promotion Parties' brands including but not limited to individuals who through speech, Social Media Platform posting or other publication, or actions condone, engage in or promote discrimination, violence, obscenity, hate speech, defamation, or libel, degrading or demeaning any group or persons based on race, religion, disability, ethnic background, sexual orientation, or sex.
 - g) By entering this Promotion, you forever fully release, discharge, indemnify, and hold harmless Meta Platforms, Inc. (including Facebook), Instagram, Threads, X (formerly Twitter), TikTok, YouTube, and any other social media platform used to promote this Promotion and on which your Participant Materials may be published (each a "**Social Media Platform**").
 - h) By participating in the Promotion, Participant agrees to the [Simon Terms of Use](#), found at <https://www.simon.com/legal> (which includes [Simon's Privacy Policy](#)), in addition to these Official Rules and to which these Official Rules are made subject. Capitalized or defined terms used in these Official Rules that are not otherwise defined in these Official Rules have the meanings given them in the Simon Terms of Use. In the event of a conflict between these Official Rules and the Simon Terms of Use, these Official Rules shall control for all matters related to the Promotion (only).
8. **PRIVACY AND PROTECTION OF PERSONAL INFORMATION:** Participant understands and agrees that Sponsor will obtain and store certain personal information, including but not limited to the full legal name, address, email address, phone number, along with general information about any Participant that completes an Entry or receives a Promotional Item (or both) for (a) the purpose of administering, managing, publishing, and promoting the Promotion including, without limitation, contacting you about your Entry in the Promotion as well as complying with applicable laws, regulations, and rules; and (b) for the purpose of sending electronic promotional messages to the Participant from the Promotion Entities and producing reports on the performance of, and Participant's activities related to, the Promotion. You understand that your personal information may be transferred for processing or storage to a jurisdiction outside of the state in which it was collected for the purposes stated in this paragraph. You have the right to request your personal information not be used for the purposes of administering,

managing, publishing, and promoting the Promotion and understand that such a request will cause you to be automatically disqualified from this Promotion, as well as potentially other existing or future promotions offered by Sponsor. 9. GOVERNING LAW; DISPUTE RESOLUTION (ARBITRATION); AND LIMITATION OF LIABILITY

a) **Governing Law.** All issues and questions concerning the construction, validity, interpretation, and enforceability of these Official Rules or the rights and obligations of Participants or Sponsor in connection with this Promotion are governed by and construed in accordance with the laws of the State of Hawaii (“**Governing Law**”) without giving effect to any choice of law or conflict of law rules (whether of the State of Hawaii or any other jurisdiction) that would cause the application of any other state's laws. You agree that all Disputes (as defined in [Section 18 of the Simon Terms of Use](#)) that may be submitted to a court pursuant to Section 9(b) of these Official Rules and [Section 18 of the Simon Terms of Use](#) must be filed in a United States District Court or state court location in the county where the Participating Center is located and you agree not to challenge or seek to remove any litigation initiated by any Promotion Party in such jurisdiction on the basis of lack of jurisdiction, *forum non conveniens*, or any other legal theory. In the event there is a discrepancy or inconsistency between disclosures or other statements contained in any Promotion materials and the terms and conditions of these Official Rules, these Official Rules shall prevail, govern, and control. b) **DISPUTE RESOLUTION (ARBITRATION); LIMITATION OF LIABILITY.** YOU AGREE THAT TO THE EXTENT PERMITTED BY APPLICABLE LAW: 1) ANY AND ALL DISPUTES ARISING OUT OF OR CONNECTED WITH THE PROMOTION, OR ANY PROMOTIONAL ITEM, INCLUDING, WITHOUT LIMITATION, ANY CLAIMS, WILL BE RESOLVED PURSUANT TO [SECTION 18 OF THE SIMON TERMS OF USE](#), WHICH INCLUDES PROVISIONS REQUIRING RESOLUTION OF CERTAIN OF THESE DISPUTES INDIVIDUALLY, WITHOUT RESORT TO ANY FORM OF CLASS ACTION OR AWARD, WITHOUT A JURY, AND BY BINDING ARBITRATION; 2) ANY AND ALL CLAIMS, JUDGMENTS, SETTLEMENTS, AND AWARDS WILL BE

LIMITED TO ACTUAL THIRD-PARTY, OUT-OF-POCKET COSTS INCURRED (IF ANY) NOT TO EXCEED THE APPROXIMATE RETAIL VALUE OF THE PROMOTIONAL ITEM, BUT IN NO EVENT WILL ATTORNEYS' FEES BE AWARDED OR RECOVERABLE; 3) UNDER NO CIRCUMSTANCES WILL YOU BE PERMITTED TO OBTAIN ANY AWARD FOR, AND YOU HEREBY KNOWINGLY AND EXPRESSLY WAIVE ALL RIGHT TO SEEK, PUNITIVE, INCIDENTAL, CONSEQUENTIAL OR SPECIAL DAMAGES, LOST PROFITS OR ANY OTHER DAMAGE, OTHER THAN ACTUAL OUT-OF-POCKET EXPENSES, IF ANY, OR ANY RIGHT TO HAVE ANY DAMAGES MULTIPLIED OR OTHERWISE INCREASED; AND 4) YOUR REMEDIES WILL BE LIMITED SOLELY TO A CLAIM FOR MONEY DAMAGES, IF ANY, AND YOU IRREVOCABLY WAIVE ANY RIGHT TO SEEK INJUNCTIVE OR EQUITABLE RELIEF. WHERE THE EXCLUSIONS CONTAINED IN THIS PARAGRAPH ARE NOT PERMITTED BY APPLICABLE LAW, THEY DO NOT APPLY.

- c) Sponsor is not responsible for any lost, late, unreadable, incomplete, damaged, stolen or misdirected Entry; lost, interrupted, or unavailable network, server or other connections; miscommunications, computer or software malfunctions; transmission problems; technical failures; garbled transmissions; damage to user's software or transmission devices; or other errors or malfunctions of any kind, whether human, mechanical, electronic or otherwise. Proof of submission will not be deemed to be proof of receipt by Sponsor. Once submitted, no Entry can be returned or confirmed. All Entries once submitted become the property of Sponsor.
