## Simon Welcome Series Brands Mass Sweepstakes Official Rules

## NO PURCHASE NECESSARY. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.

- 1. Eligibility: The Simon Welcome Series Brands Mass Sweepstakes (the "Sweepstakes") is open only to legal residents of the forty-nine (49) United States (excludes Rhode Island), the District of Columbia and Puerto Rico who are at least eighteen (18) years old at the time of entry and received an emailed invitation to participate in the Sweepstakes during the Promotion Period (as defined below). - **3. Agreement to Official Rules:** Participation in this Sweepstakes constitutes entrant's full and unconditional agreement to these Official Rules. Sponsor's and Administrator's decisions are final and binding in all matters related to this Sweepstakes. Winning a prize is contingent upon fulfilling all requirements set forth herein.
- **4. Timing:** The Sweepstakes begins on March 1, 2025 at approximately 12:00 a.m. Eastern Time ("ET"), ends on February 28, 2026 at 11:59 p.m. ET (the "Promotion Period") and consists of four (4) entry periods (each, an "Entry Period"). Sponsor's servers are the official time-keeping devices for the Sweepstakes.

**5. How to Enter:** During the Promotion Period, follow the links and instructions provided to you by email to complete and submit the survey and registration form, including providing your first name, last name, valid email address, Zip code and agreement to these Official Rules. You must complete all questions in the survey in order to be entered into the Sweepstakes. Upon submitting the survey and agreeing to these Official Rules you will receive one (1) entry into the Entry Period drawing associated with the date and time you submitted your survey.

<u>Limit</u>: Each entrant may receive one (1) Sweepstakes entry during the Promotion Period. Multiple entrants are not permitted to share the same email address. Any attempt by any entrant to obtain more than one (1) entry by using multiple/different email addresses, identities, survey links, registrations and logins or any other methods will void that entrant's entries and that entrant may be disqualified. Use of any automated system to participate is prohibited and will result in disqualification. In the event of a dispute as to the identity of an entrant, Sponsor and Administrator will rely on the information submitted by the entrant to register for this Sweepstakes. If any additional information provided by entrant is inconsistent with the information provided at registration for this Sweepstakes, Sponsor and/or Administrator may disqualify such entrant and such disqualification may result in the forfeiture of any prizes won. require additional documentation from entrant to show proof of entrant's identity.

**6. Winner Determination and Verification:** Administrator is an independent organization whose decisions as to the selection of the potential winners are final and binding. Administrator will randomly select the potential Sweepstakes winners from all eligible entries received during the applicable Entry Period, on or around the dates set forth in the table in Section 3. Nonwinning entries will not be included in subsequent Entry Period drawings. The potential winners will be notified by Administrator at the email provided at registration soon after the applicable Entry Period drawing. Potential winners may be required to provide their name, home mailing address (P.O. Boxes may not be permitted), and date of birth to confirm eligibility and for purposes of prize fulfillment within three (3) days of the date notice or attempted notice is sent in order to claim the prize. - **C. Odds of Winning:** The odds of winning a prize depend on the total number of eligible entries received during the applicable Entry Period.

maximum extent possible. In addition, if any provision contained in these Official Rules shall for any reason be held to be excessively broad as to duration, geographical scope, activity or subject, it shall be construed by limiting and reducing it, so as to be enforceable to the extent compatible with applicable law.
